I. RELEASE OF LIABILITY -- READ BEFORE SIGNING

In consideration of being allowed to participate in Hardkour Ninja Zone, LLC d.b.a. Hardkour Ninja Unlimited's (HKNU) program, related events and activities, I, _____, the undersigned, individually or as parent or Guardian of the minor participant, _____, acknowledge and agree that:

- A. Participation in Parkour and Freerunning training and instruction activities and related activities inside and outside this facility entails known and unanticipated risks that could result in physical or emotional injury, paralysis, death, or damage to the participant, to property, or to third parties. I understand that such risks simply cannot be eliminated despite our best efforts;
- B. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS;
- C. I agree to comply with all rules and conditions for participation. If, however, I observe any significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of HKNU personnel immediately; and
- D. I, individually and on behalf of my heirs, assigns and personal representatives, HEREBY RELEASE, INDEMNIFY, AND HOLD HARMLESS HKNU, its officers, officials, agents and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and, if applicable, owners and lessors of premises used for the activity, WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property to the fullest extent permitted by law.

II. HKNU RULES

- A. HKNU may suspend or cancel the rights, privileges, or membership of any member whose actions are detrimental to the enjoyment of the facilities by other members or any conduct which in the opinion of the management is prejudicial to welfare, good order, and character of HKNU. Any inappropriate behavior, including profanity or yelling, incidental to the enjoyment of the gym by other members may result in membership termination without a refund and any registration fees shall be forfeited. HKNU has the right to cancel any membership for non-payment of their membership account balance.

III. AUTHORIZATION FOR MEDICAL TREATMENT

- A. Permission for Emergency Medical Treatment: I confirm that I am/my child is in good health and I hereby authorize simple first aid and consent to any x-ray, exam, and medical or surgical diagnosis which is deemed necessary in case of an emergency, and agree that I will be responsible for the costs of any such treatment.

IV. DEFAULT

- A. I hereby agree that I am responsible for all costs incurred for the collection of any delinquent payments, including but not limited to reasonable attorney and collection fees.

V. AUTHORIZATION TO USE INFORMATION, IMAGES

- A. I give my permission for photos and videos of myself/my child taken during classes, open gyms, and/or competitions to be used on HKNU's website, social media, and other marketing materials.
